May minutes were presented. A motion by Greg to approve the regular meeting minutes, 2<sup>nd</sup> by Gary. Motion carried.

Treasurer's report was given - The balance the end of May was \$37,881.44 and after paying the bills it is \$14,770.43. A motion by Dean to approve the treasurer's, 2nd by Greg. Motion carried.

Patrolman's Report - All roads are patched - used 22-1/2 ton. Rusk County had a fatality so we need warning lights on grader and the backhoe. Our 1996 mower tractor has 4672 hours on it - has shifting problems so it would cost at least \$12,600 to repair. Also has a pressure problem. Trade in possible if we put new tires on it. The boom mower has been welded many times. Dean made a motion to authorize Andy to get trade in numbers. 2nd by Greg. Motion carried.

Will be graveling 170th the last week of June if Darryl's gravel gets crushed.

Greg made a motion to go into closed session per Wis Statutes 19.85(1)(c) and (g). Gary seconded it. Motion carried.

Greg made a motion to go back into Open session. Dean seconded it. Motion carried.
